



PEOPLE'S REPUBLIC OF CHINA

BUSINESS VISA REQUIREMENTS:

1. Passport

You must provide your actual signed passport. Your passport must:

- Be valid for six months beyond the length of your requested visa (for example, if you are requesting a 12 month visa your passport must be valid for 18 months)
- Have at least one blank visa page (amendments and endorsement pages cannot be used)

2. Photographs

You must provide one color, passport-type photograph. The photograph must:

- Be printed on photo paper
- Be two inches by two inches
- Have a white background
- Have been taken within the last six months

3. Business Introduction Letter

A letter of introduction from your US-based company is required. Your completed introduction letter must:

- Be printed on your company's official letterhead with the address and the phone number
- Display your full name, nationality, and job title
- Specify the exact purpose of your trip
- Specify the number of entries requested
- Include the validity of your requested visa
- Be signed by your supervisor or your company's Human Resources department

4. Invitation Letter

You must obtain a letter of invitation. The organization you will be visiting is responsible for obtaining the invitation. A copy is acceptable. This letter must:

- Include the full local address and phone number of the organization or person to be visited
- Request the same validity of visa as in the Business Introduction Letter.
- Be written on company letterhead
- Be signed Letter of invitation from P.R.China

You must provide one completed visa application form. The application form must:

- Include answers for all fields
- Display your full name as it appears in your passport
- Be signed

7. Photocopy of All Application Materials

You must provide photocopies of all items that you submit to IRTC. Your photocopies must be provided along with the original version of each document. If you prefer that IRTC make photocopies for you, additional fees will be applied to your order.

Chinese Born Citizens

If you were born in China, you must write your name in Chinese characters for question 1.3 on the visa application form. If you have been previously issued a China visa in your current or expired passport you must submit a copy of that visa. If you have never been issued a China visa you must submit your original Chinese passport or birth certificate showing your name in Chinese characters.

TOURIST VISA REQUIREMENTS:

1. Passport

You must provide your actual signed passport. Your passport must:

- Be valid for six months beyond the length of your requested visa (for example, if you are requesting a 12 month visa your passport must be valid for 18 months)
- Have at least one blank visa page (amendments and endorsement pages cannot be used)

2. Photographs

You must provide one color, passport-type photograph. The photograph must:

- Be printed on photo paper
- Be two inches by two inches
- Have a white background
- Have been taken within the last six months
